Terms

The Centre shall not be held liable under any circumstances for the inability of the Hirer to make full use of the equipment provided, whether this be caused by the Hirer having selected inadequate or unsuitable equipment or services, the venue being unsuitable for intended purpose of access to the venue being inadequate with respect to installing the chosen equipment.

The Centre will test all equipment before the agreed date of hire and confirm all equipment is working at time of hire.

It is the Hirers responsibility to ensure all equipment is complete and in working order. The Centre cannot be held liable for any defect or failure.

The Hirer accepts full responsibility for any damage or breakages to equipment while it is in their possession and care. Under such circumstances, no compensation may be sought by the Hirer.

Equipment Hire Terms and Conditions
